- Number of hounds tested. 28 dogs entered. 2 reported absent, 26 dogs ran. An abundance of dogs
 entered qualified, some dogs for their first qualifying scores.

- What was the condition of the grounds for the event?
 - Weather on Sunday started off chilly, with lows in the upper 30s. Skies were cloudy and the wind was present but not overbearing. The field was slightly more dry than on Saturday, but dogs were still able to start rabbits and continue on pursuits, though some pursuits were shorter and dogs were losing odor faster than on Saturday.

Additional comments:

- During run 2 (Pack run) one dog was unable to be picked up in time. It was decided by the handlers on run 3 to proceed with their run, and to attempt to pick the dog up during the pack run. The dog was difficult to catch, but honored her new pack and hunted well. She was eventually caught by Mary, and her owner retrieved the dog and brought her back to camp. The pack run continued with the 3 original dogs, and the rest of the day continued as intended.
- During run 6 (Pack run), a handler fell on the field. While no injuries were sustained, she decided to leave the field and pull her dogs from the pack. The judges excused both dogs, and the remaining 3 dogs continued their run.

- Abby from Tarheel Beagle Club made breakfast and lunch again, and the meals were again well-received by the hunt attendees. Keith, Tarheel Beagle Club Secretary, was also in attendance during the morning meeting, so hunt attendees were sure to thank him and their club for their hospitality during our event.
