 - iv. Registration will be via mail only. Sharon said that we do have a PayPal account now if anyone prefers to pay entry fees online vs. mailing their payment. So few people have paid online in the past that we are not including this option in the premium. However, if someone wants to use PayPal, reach out to Paul.
 - v. There are judges assigned.
 - vi. Betty and Les White will be in charge of Marshals.
 - vii. The Beagle Club also obtains the hunting permit.
 - viii. Sharon will request the insurance certificate and make it available at the hunting grounds.
 - ix. Phyllis will bring the starter gun and collars.

IV. Update on the Website – Sharon Kimble, Paul Urban

- a. Paul shared that the company we use to host our website, Host Monster, has been acquired by Blue Host. We used to be able to create and update web pages using What You See Is What You Get (WYSIWYG) within the Host Monster tools. Now that Blue Host has taken over, we no longer have the WYSIWYG tools. We can use WordPress or HTLM code to update pages. We don't know how to use WordPress yet and pages cannot be updated with WordPress; they have to be recreated using WordPress. Paul and Sharon can update pages using HTML code, but it is tedious work.
- b. There are many photos on the website that we don't want to lose. The group briefly discussed possible options for moving photos to a hosting site, something like Shutterfly.
- c. We are sharing this to let everyone know that website updates may take longer than usual.
- d. We are also sharing in case someone knows someone with WordPress experience that might be able to help us transition website pages to WordPress. If you do, please reach out to Paul or Sharon.

V. 2026 Officers & Board of Directors – Phyllis Lindquist, President
